Subject : Customs - Amendment to Sea Cargo Manifest and Transshipment  
Regulations, 2018 - Issue of amendment to Public Notice – Reg.

Attention of all the Importers, Exporters, Customs Brokers, Steamer Agents, Custodians/Customs Cargo Service Providers, Trade Associations/Chamber of Commerce, Members of the RAC/PGC and the Public is invited to Notification No.38/2018-Customs (N.T.) dated 11.05.2018 notifying Sea Cargo Manifest and Transshipment Regulations, 2018, effective from 1<sup>st</sup> August, 2018 which was communicated vide this office Public Notice No.25/2018-Customs, dated 21.05.2018 and amendments thereon from time to time.


CBIC, New Delhi, vide Notification No.14/2020-Customs (N.T.), dated 14.02.2020 has again issued certain amendments to the Sea Cargo Manifest and Transshipment Regulations, 2018. The amendments to the said Regulations are furnished hereunder for information and compliance.

In exercise of the powers conferred by section 157, read with sections 30, 30A, 41, 41A, 53, 54, 56, sub-section (3) of section 98 and sub-section (2) of section 158 of the Customs Act, 1962 (52 of 1962), the Central Board of Indirect Taxes and Customs hereby makes the following regulations further to amend the Sea Cargo Manifest and Transshipment Regulations, 2018, namely: -

1. Short title and commencement. –

- (i) These regulations may be called the Sea Cargo Manifest and Transshipment (Amendment) Regulations, 2020.

- (ii) They shall come into force on the date of their publication in the Official Gazette.
2. In the Sea Cargo Manifest and Transhipment Regulations, 2018, in Regulation 15.
- a. in sub-Regulation (1), for the expression, "for the period of forty-five days from the date of commencement of these regulations", the expression, "from 15<sup>th</sup> May, 2020 till 1<sup>st</sup> August, 2020" shall be substituted.
- b. in sub-Regulation (2), for the figures and letters "16<sup>th</sup> February, 2020", the words, figures and letters "till 1<sup>st</sup> August, 2020" shall be substituted.
3. Action to be taken in terms of decisions taken in this Public Notice should be considered as **standing order** for the purpose of officers and staff.
