ANNEXURE-I

(Terms and conditions)

1. The vessels can be inspected for the works to be carried out at the location as mentioned above on any working days with prior intimation.
2. You may also inspect fitted systems and equipment of **each** vessel and their controls for any defects for consideration for estimation.
3. For Service routines & repair works of OBMs of Mercury Mariner 250 HP EFI Engines The firm should be an authorized dealer of Mercury Marine (OBM), having workshop facility for overhauling of OBMs and should be able to arrange all requisite spares.
4. For Deck side overall repair works of vessel, the firm should have an **experience of at least 03 (three) years with sufficient manpower and presently handling similar nature of work.**
5. All spares, consumables, paints, oil & lubricants, materials etc, required to carry out repairs shall be supplied by the firms including crane services and transportation, if required.
6. After completion of works, sea trials at full powers to be conducted for satisfactory performance of all machineries, equipment and systems fitted on **each** vessel.
7. The work carried out should be guaranteed for a period of six months from the date of successful trials of each vessel.
8. The firm is required to complete the repair works and sea trials within 30 days from the date of work order. In case the repairs are not completed within the time frame, liquidated damage of Rs. 5000/- per week per each vessel till completion of works and sea trials shall be deducted from the payment.
