### FACILITY CIRUCULAR No.01/2020 - Customs

Subject: Customs – Issuing of Online Customs Cargo Pass for hassle free movement of Export and Import Cargo - – Regarding.

Attention of all Importers, Exporters, Customs Brokers, Shipping Lines/Agents, Custodians/Customs Cargo Service Providers, Port Terminal Operators, General Trade / Trade Associations / Chamber of Commerce and all other stakeholders & the Public, coming under the jurisdiction of Commissionerate of Customs (Preventive), Vijayawada, is invited to the above mentioned subject.

- 2. Many representations are received from various members of trade regarding the difficulties in the movement of the import and export cargo, due to undergoing lock down announced by the Government as part of COVID-19 control measures. Considering the economic security of the nation and to ensure the flow of essential goods to the society without any hindrance, it is decided that "Essential Services of Customs Cargo Pass during COVID-19" will be issued for all the vehicles carrying import and export cargo (in the format enclosed), for hassle free movement of Export and Import Cargo.
- 3. For the movement of containers from terminals to CFS/ Factory, pass shall be issued by the Customs Gate officers posted in the concerned terminals. In case of movement of containers from CFS to terminal, officers posted in concerned CFS shall issue the Customs Cargo Pass.
- 4. Further, to facilitate the movement of self sealed export containers with DPE facility and the movement of export cargo from the factory to the CFS for stuffing, it is decided to issue online Customs Cargo Pass. To avail this online facility, exporters may send a request mail along with relevant details such as shipping Bill number, Container Number, Commodity Name, Address of the factory, name and the address of the Port/CFS, likely Date and Time of Cargo movement, to the Docks Admin Section of respective formation i.e., at <a href="mailto:cus.kpport@gmail.com">cus.kpport@gmail.com</a> for Krishnapatnam Custom

House ; at <a href="kkdcustomhouse@gmail.com">kkdcustomhouse@gmail.com</a> for Kakinada Custom House ; and at <a href="customsicdmarripalem@gmail.com">customsicdmarripalem@gmail.com</a> for ICD Marripalem. Based on the request provided by the exporter, the Assistant Commissioner/ Deputy Commissioner, Export Assessment of the concerned port will issue the vehicle pass and the scanned copy of vehicle pass shall be sent to the exporter's mail id.
