PUBLIC NOTICE NO.35/2020-CUSTOMS

Subject: Turant Customs- Constitution of Turant Suvidha Kendras (TSKs) - Reg.

Attention of all Importers, Exporters, Customs Brokers, Shipping Lines/ Agents, Custodians/Customs Cargo service Providers, Port Terminal Operators, General Trade/Trade Associations/Chamber of Commerce and all other stakeholders & the Public, coming under the jurisdiction of Commissionerate of Customs (Preventive), Vijayawada, is invited to Board's Circular No.32/2020-Customs, dt.06.07.2020 and this Office Public Notice No.34/2020-Customs, dt.09.07.2020, on the above subject, where in it was mentioned that under the 'Turant Customs' programme aimed at providing a 'Faceless, Contactless and Paperless' Customs administration, Board has recently introduced a number of initiatives that leverage technology in order to enhance the efficiency in the Customs clearance processes thereby leading to speedy clearances, transparency in decision making, ease of doing business and very importantly, reduce physical contact in the prevailing pandemic situation. These initiatives include, amongst others, automated clearances of Bills of Entry, digitalization of Customs documents, paperless clearance, Faceless Assessment and Establishment of Turant Suvidha Kendra at Bengaluru and Chennai vide Circulars No.05/2020-Cus, dt.27.01.2020, No.19/2020-Cus., dt.13.04.2020 and No.28/2020-Cus., dt.05.06.2020 respectively and this Office Public Notice No.34/2020-Cus., dt.09.07.2020 on the above subject.

Turant Suvidha Kendra in all Customs Formations:-

Circular No.28/2020-Cus., dt.05.06.2020 provided for setting up of Turant Suvidha Kendras (TSK) for the purpose of implementation of 1st phase of Faceless Assessment at Bengaluru and Chennai and Instruction No.09/2020-Cus., dt.05.06.2020, details the roles and functions of TSKs. Considering the benefits ushered in by providing single point interface, Board has decided to extend TSKs to all the Customs formations for carrying out the functions mentioned in Para 5 of the said Circular. The following Turant Suvidha Kendras under the jurisdiction of Customs Commissionerate (Preventive), Vijayawada, are constituted comprising of Offices mentioned against the Custom House, for facilitation to the trade w.e.f. 15.07.2020.

The Role of Turant Suvidha Kendras are detailed below:-

- i. The document verification by Customs Officers at Assessment and Customs Compliance Verification (CCV) stages would normally be based on the documents uploaded in the e-Sanchit, not requiring physical submission of documents. However, if in any exceptional situation the physical submission of documents is required by Customs, for defacement or validation, such submission would be made only at the TSKs.
- Documents requiring verification during examination for validation with goods would continue to be done during examination, as at present.
- Action to be taken in terms of decisions taken in this Public Notice should be considered as Standing Order for the purpose of officers and staff.
