Subject : Customs - Amendment to Sea Cargo Manifest and Transshipment Regulations, 2018 - Issue of amendment to Public Notice – Reg.

Attention of all the Importers, Exporters, Customs Brokers, Steamer Agents, Custodians/Customs Cargo Service Providers, Trade Associations/Chamber of Commerce, Members of the RAC/PGC and the Public is invited to Notification No.38/2018-Customs (N.T.) dated 11.05.2018 notifying Sea Cargo Manifest and Transshipment Regulations, 2018, effective from 1st August, 2018 which was communicated vide this office Public Notice No.25/2018-Customs, dated 21.05.2018 and amendments thereon from time to time.

Further, the CBIC, New Delhi, vide Notification No.94/2020-Customs (N.T.), dated 30.09.2020 has again issued certain amendments to the Sea Cargo Manifest and Transshipment Regulations, 2018. The amendments to the said Regulations are furnished hereunder for information and compliance.

In exercise of the powers conferred by section 157, read with sections 30, 30A, 41, 41A, 53, 54, 56, sub-section (3) of section 98 and sub-section (2) of section 158 of the Customs Act, 1962 (52 of 1962), the Central Board of Indirect Taxes and Customs hereby makes the following regulations further to amend the Sea Cargo Manifest and Transshipment Regulations, 2018, namely: -

1. Short title and commencement. –

- (1) These regulations may be called the Sea Cargo Manifest and Transshipment (Third Amendment) Regulations, 2020.

- (2) They shall come into force on the date of their publication in the Official Gazette.
2. In the Sea Cargo Manifest and Transshipment Regulations, 2018 (hereinafter referred to as the said regulations), **in Regulation 3, in Sub-regulation (1A):-**
- for the words, “**ten lakhs**”, wherever they occur, the words, “**five lakhs**” shall be substituted;
 - in the proviso, for the words, brackets and letters, “**Authorised Economic Operator (AEO)**”, the words, brackets, letters and figures, “**Authorised Economic Operator (AEO) and Customs Broker licensed under the Customs Brokers Licensing Regulations, 2018**” shall be substituted.
3. In the said regulations, **in Regulation 15:-**
- in sub-Regulation (1), for the words, figures and letters, “from 15th May, 2020 **till 30th September, 2020**”, the words, figures and letters, “**till 01st November, 2020**” shall be substituted.
 - in sub-Regulation (2)**, for the words, figures and letters “**till 30th September, 2020**”, the words, figures and letters “**till 31st March, 2021**” shall be substituted.
4. Action to be taken in terms of decisions taken in this Public Notice should be considered as **standing order** for the purpose of officers and staff.
