All the Importers , Exporters , Customs Brokers , Steamer Agents , Stake Holders, Custodians /Customs Cargo Service Providers, Trade Associations / Chamber of Commerce , Members of the RAC/PGC and the Public in general is hereby informed that the Government of India vide Notification No.78/2014 –Cus (NT) dated 16-09-2014 has notified inter-alia the jurisdiction of the newly formed Customs Preventive Commissionerate at Vijayawada under Visakhapatnam Zone and consequently the Chief Commissioner of Customs , Central Excise & Service Tax, Vizag Zone vide Public Notice No. 1/2014 / General No. 2/2014 dated 07-10-2014 has defined the jurisdiction of Customs Preventive Commissionerate at Vijayawada under Visakhapatnam Zone.
