Sub: De-notification of Container Freight Station (CFS) of M/s. Seabird Distriparks (Krishnapatnam) Private Ltd. (formerly known as M/s Krishnapatnam Bay Area CFS Private Limited) - Reg.

Attention is invited to Notification No. 03/2017-Customs dated 24.11.2017, wherein the Commissioner of Customs, Vijayawada, had declared the area of M/s. Seabird Distriparks (Krishnapatnam) Private Ltd. (formerly known as M/s Krishnapatnam Bay Area CFS Private Limited) situated at Survey No.1709 of Epuru (BIT 1A), Epuru Village, Krishnapatnam Port Area, Near Loco Shed, Muthukuru Mandal, SPSR Nellore District, Andhra Pradesh-524344 as a Customs Area and specified its limits to an extent of 59,312 Sq. Mtrs. under Section 8(a) and 8(b) of the Customs Act, 1962.

Pursuant to the request of M/s. Seabird Distriparks (Krishnapatnam) Private Ltd. and after due examination of the application, I, Ramesh Kumar Raman, Commissioner of Customs, Customs Commissionerate (Preventive), Vijayawada, in exercise of the powers conferred under Section 8 of the Customs Act, 1962 hereby de-notify the Customs Area of M/s. Seabird Distriparks (Krishnapatnam) Private Ltd. admeasuring 59,312 Sq.Mtrs (15.123 Acres) situated at Survey No.1709 of Epuru (BIT 1A), Epuru Village, Krishnapatnam Port Area, Near Loco Shed, Muthukuru Mandal, SPSR Nellore District, Andhra Pradesh-524344 with immediate effect. The boundaries of the de-notified Customs area are as follows:

North: Railway parking bay bounder is 494.52 meters.

West: Port land bounder is 124.27 meters.
East: Port land bounder is 123.6 meters.
South: Main road bounder is 494.68 meters.
