{Addendum to Public Notice No. 01/2022- Dt.01.02.2022}

Subject: Customs – Drawal of one composite sample for one vessel in respect of imports of Edible Oils—Further extension of validity—Reg.

Attention of all the importers, Custom House Agents and the Members of the Trade is invited to the Public Notice No. 01/2022 dt.01.02.2022 issued by this Office, regarding drawal of one composite sample for one vessel in respect of the consignment of import of edible oils, in the light of the difficulties expressed by the Trade regarding the practice of drawing the samples from each and every tank of a vessel and to avoid cost and delays etc.,

02. In the light of the same, the facility of drawal of one composite same for one vessel in respect of imports of Edible oils has been extended for an initial period of three months i.e., up to 30.04.2022 {three months period from the date of issuance of the said Public Notice No. 01/2022 dt.01.02.2022}.

03. A fair review of the said facility revealed that obtaining the test results from the FSSAI approved JNTU, Kakinada lab with the additional testing parameters of the edibility is time saving, quick results and more convenient in comparison with obtaining the test reports from the CRCL Lab, Visakhapatnam; no negative remarks / misuse of the facility observed; the trade has overwhelmingly welcomed the measure.

04. In the light of the same, the facility of the drawal of one composite sample for one vessel in respect of the consignment of import of edible oils, has been extended for a further period of 6 (six months) with effect from 01.06.2022 i.e., up to 30.11.2022.
