Attention of the stakeholders is invited to NACIN, Faridabad Letter F.No. NACIN/Sys/2/2022-EXAM/4068 dated 21.12.2023, wherein reference is made to the final judgements dated 20.07.2023 and 24.07.2023 ofHon'ble High Court of Delhi against WP(C)9591/2023 and WP(C)2143/2023 respectively.
