# SELF SEALING PERMISSION

This Self Sealing Permission (SSP) is hereby granted to M/s. ### **CONDITIONS:**

- 3. This Self Sealing Permission is valid for the goods, as declared except prohibited goods, under all applicable schemes
- 4. No corrections/ changes/ amendments in the SSP will be valid unless the request for any correction/changes/amendments is applied for and approved by the competent authority.
- 5. This SSP shall remain valid till the permission holder carries on the activity for which it has been issued or surrenders it or till it is revoked/suspended by the competent Authority. In case, something adverse is noticed against the exporter, the customs station concerned shall promptly intimate the custom house which has granted the factory stuffing permission which will, in turn, withdraw suspend/hold in abeyance the permission accorded, and inform all custom houses concerned.
- 6. The grant of this permission shall be without prejudice to any other action that may be taken by such other agencies over the premises or purpose to which such agencies may require to enforce such laws to be complied by the unit.
- 7. Prior intimation shall be submitted to the jurisdictional Customs authorities, one day in advance, before commencement of exports.
- 8. The exporter shall seal the stuffed containers with electronic seal i.e., "RFID tamper proof one-time-bolt seal each bearing a unique serial no. and brand of vendor
