CONDITIONS:

1. This Self Sealing Permission is valid for the premises and purpose specified in the application.

3. This Self Sealing Permission is valid for the goods, as declared except prohibited goods, under all applicable schemes
4. No corrections/ changes/ amendments in the SSP will be valid unless the request for any correction/changes/amendments is applied for and approved by the competent authority.
5. This SSP shall remain valid till the permission holder carries on the activity for which it has been issued or surrenders it or till it is revoked/suspended by the competent Authority.
