3. At the outset, the Commissioner of Customs welcomed the Exporters, Custodian, Customs Broker Licence holders and the Officers of ICD, Marripalem.

4. Then, Sri V. Sambaiah, COO of M/s. Spads Redfields Exim P Ltd., raised the issue of grant of IGST refund for exports done under LUT. The Commissioner explained that for exports done under LUT, IGST refund will not be granted by the Customs and that their Central Tax Range Officer form GST Commissionerate will grant ITC.

5. Shri G. Yugandhar, Manager, M/s. Mohammad Enterprises Ltd., also had a point regarding payment of IGST and the Commissioner directed them to approach the jurisdictional GST range officer. Further, the Commissioner requested the exporter to approach Customs Commissioner's office in Vijayawada so that their concerns will be taken up in liaison with the CGST Amaravathi Division Officers.

6. The Commissioner enquired about the EGM errors and the exporters in respect of whom the IGST refund is pending due to errors in Gateway EGMs. The Commissioner observed that in respect of SBs pertaining to M/s Merlion Impex Pvt Ltd there are 10 Gateway EGM errors and in respect of M/s. Nukala Ramakoteswara Rao

there are 6 Gateway EGM errors were pending in error code SBoo6 i.e; Gateway EGM not closed. The Commissioner directed that the respective exporters shall be informed regarding the errors and to request them to get the Gateway EGMs closed by their shipping liners. The Commissioner directed that the list of EGM errors shall be taken Liner-wise and direct the liners to file the supplementary EGMs immediately. Further, the Commissioner asked whether the CHAs are advising their exporters on the errors in the Gateway EGMs. The Commissioner directed that the list shall be communicated to the exporters directly through e Mail and informed that the exporters have to take interest in knowing whether the shipping lines have filed their EGMs or not.

7. Before concluding the meeting, the Commissioner has asked the trade to present their queries / suggestions / grievances if any, for betterment of the procedures FOR ease of doing business.
