The Office of the Principal Chief Controller of Accounts, Central Board of Indirect Taxes & Customs, New Delhi vide Office Memorandum Coord / 2 (1) / Guntur (25) / 2018 - 19 / 64 dated 04.05.2018 communicated the approval for change of Focal Point Bank of State Bank of India from Vizag to Guntur for Customs duty collection and payment of duty drawback under EDI System in respect of Kakinada Custom House under the Commissionerate of Customs (Preventive), Vijayawada.
