#### PUBLIC NOTICE No. 18 /2018

Sub: Customs - "G" Card Examination - Issue of Public Notice - Reg

Attention of the trade and all public is invited to Regulation 17 (3) of the Customs Brokers Licensing Regulations, 2013. In terms of the provisions contained therein, fresh applications are invited in prescribed proforma for the written examination, which is proposed to be conducted on 15.05.2018 (Tuesday) (from 10.00 hours to 13.00 hours).

2. The Category "G" Examination consisting of two parts (i) Written Examination and (ii) Oral Examination. The written examination is for 100 marks and Oral Examination is for 50 marks and the minimum qualifying marks will be 50% of marks under each category. An applicant will be declared to have passed in the examination only when he / she secures minimum 50% of marks each in both written and oral examination.

Each applicant would be permitted to avail maximum of 4 chances or attempts to qualify in the written and oral examination from his/her first appearance for written examination. Non-appearance in any written or oral examination will not be counted as a chance or an attempt. An example has been worked out and illustrated as follows:

Illustration: A person who qualifies in the written examination in the first chance /attempt but fails to qualify in the oral exam linked to the written examination will get another three chances/attempts for oral examination. If a person qualifies only in his fourth (last) chance/attempt in the written examination, he will get only one chance for oral examination linked to the written examination in which he qualifies.

- 3. After qualifying both parts of the said examination (written & oral) an employee of the Customs Broker will become eligible to hold power of attorney on behalf of the Customs Broker.
- 3.1 The facility of appearing in only oral test by person who have qualified in written exam will be applicable only from this year onwards. Those who have qualified in written exam but failed in oral test in 'G' card exam conducted by this office previously have to appear for written exam again this year.

# GUIDELINES TO THE APPLICANTS WHO ARE APPLYING FIRST TIME FOR THE EXAMINATIONS:

#### 4. Eligibility Criterion:-

An employee / director / partner of Customs Broker who have passed 10+2 or equivalent exam.

5. Format for applications: The applications duly sponsored by the Customs Brokers should be submitted in the format as prescribed at PROFORMA enclosed as ANNEXURE – A to this Public Notice. Applicants may ensure furnishing full postal address for communication, email and their mobile number properly for prompt communication.

#### 6. Documents to be attached with applications:-

- (a) Xerox copy of the Customs Pass held presently, attested by a gazette officer.
- (b) Photocopy of certificates regarding declared pass in 10+2 or equivalent examination attested by a gazette officer.
- (c) TR-6 Challan for Rs. 500 /- against examination fees.
- (d) Three recent passport size color photographs (mentioning their name overleaf)
- 7. After passing the written part of the Examination, the candidates will have to appear for the Oral Test, to be conducted on 08.06.2018 at Krishnapatnam Custom House, Kakinada Custom House and ICD, Marripalem, Guntur District. All the authorized Customs Brokers are accordingly requested to ensure that their employees prepare themselves for the said examination regarding provisions of the Act subject to which goods and baggage are cleared through Customs.

- 8. All the authorized Customs Brokers are requested to ensure that the information given in respect of their employees is true and correct. Any mis-declaration will be viewed seriously and suitable action will be initiated in accordance with Customs Brokers Licensing Regulations, 2013.
- 9. Willing Authorized Customs Brokers are therefore advised to submit application(s) in respect of their present eligible employees who are willing to appear in the said examinations (in Annexure A), with respective Customs Stations i.e. Custom House, Krishnapatnam, ICD, Marripalem, Guntur District and Custom House, Kakinada on or before 28.04.2018 up to 02.00 PM.
- 10. After Scrutiny, the In-charge of jurisdictional Custom stations i.e. Custom House, Krishnapatnam, ICD, Marripalem and Custom House, Kakinada shall submit the applications in Annexure A received from the eligible employees of respective Authorized Customs Brokers and submit to the Office of the Commissioner of Customs (Preventive), 2<sup>nd</sup> Floor, Door No. 55-17-3, C-14, 2<sup>nd</sup> Road, Industrial Estate, Auto Nagar, Vijayawada 520 007, by 01.05.2018 through Special Messenger.
- 11. The In-charge of jurisdictional Custom stations should ensure that no correspondence with applicants / Customs Brokers on discrepancies in the applications for rectification of errors / omissions in the said applications is entertained.
- Last date for receipt of applications: Applications can be submitted through the Jurisdictional Custom stations i.e. Custom House, Krishnapatnam, ICD, Marripalem, Guntur District and Custom House, Kakinada on or before **02.00 PM on 28.04.2018**. The applicants sending their applications by post should ensure that the same are reached to the concerned authority within the prescribed time. Applications not in the prescribed format or received after expiry of the last date i.e. after **02.00 PM on 28.04.2018** will not be entertained under any circumstances.
- 13. The Joint Commissioners of Customs, Krishnapatnam and Kakinada Custom Houses and the Deputy Commissioner of Customs, ICD, Marripalem, Guntur District may ensure furnishing of a list of total applications (specifically mention whether the

applicant fulfilled the conditions or not) received, by 18.00 hours on 28.04.2018, without fail, by email to cpcvijayawada@gmail.com and cpcvja.tech@gmail.com.

- 14. The Roll Nos. of eligible candidates, time and venue of the written examination will be displayed on the Notice Board of respective Custom Formations and in official website of the Commissionerate i.e. www.apcustoms.gov.in.
- Hall tickets for the Written Examination and intimation about Oral Examination will be communicated through the In-charge of Customs Stations where the applications submitted by the candidates i.e. through the Joint Commissioners of Customs, Krishnapatnam and Kakinada Customs Houses and Deputy Commissioner of Customs, ICD, Marripalem and the information will also be displayed in the official website of this office i.e. www.apcustoms.gov.in.
