Subject: - Introducing New accounting codes under Major Head 0037 for the purpose of Accounting of Collecting Road & Infrastructure Cess and Social Welfare Surcharge – Regarding.

Attention of all the Importers, Exporters, Customs Brokers, Steamer Agents Custodians/Customs Cargo Service Providers, Trade Associations / Chamber of Commerce, Members of the RAC / PGC / CCFC and the public is invited to the Office Memorandum No. Coord/13-6/H/A/cs/Vol.VIII/2018-19/37 dated 19.04.2018 of Office of Principal Chief Controller of Accounts, Central Board of Indirect Taxes and Customs, New Delhi on the above subject. In the said Office Memorandum, PCCA, CBIC has inter-alia communicated certain corrections / charges made in the Major Head "0037 – CUSTOMS" for remittance of Road and Infrastructure Cess and Social Welfare Surcharge under proper Head of Accounts by mentioning their eight digit code.
