### PUBLIC NOTICE No. 02 / 2021 - Customs

Subject: Invitation of Applications for empanelment of Chartered Engineers for examination/valuation of Second / Old & Used machinery/goods etc., -Regarding.

Attention of all Importers/ Exporters / Customs Brokers, Members of the Trade bodies and general public is invited to the CBEC Circular No. 07/2020-Customs dated 05.02.2020 issued by Central Board of Indirect Taxes & Customs regarding valuation of secondhand machinery.

- O2. In terms of the above Circular dated 05.02.2020, this Office propose to draw a Panel of Chartered Engineers for the purpose of valuation of Second hand / Old & Used imported machinery, equipments, other capital goods, computers, photocopiers/ MFDs, office equipments, tools etc. and their parts/accessories. Accordingly, applications are invited in the prescribed proforma from Chartered Engineers (Individual / Proprietor /Partnership / Company) duly affiliated to or recognized by the Institution of Engineers (India) to empanel Chartered Engineers for valuation of imported secondhand machinery etc.,.
- 03. The work requires high degree of professional expertise, integrity and fairness. Matters may be referred to them seeking expert opinion on valuation of subject goods. In the case of second hand / old & used machinery, equipments, other capital goods, computers, photocopiers/MFDs, office equipments, tools etc. and their parts/accessories, the Chartered Engineers are required to prepare their report in accordance with CBEC Circular No. 07/2020-Customs dated 05.02.2020, after verification of the goods.

- O4. The applicants shall submit application in the prescribed proforma and prescribed undertaking (Refer Annexure-A-I, A-II, A-III & conditions as per Annexure-B enclosed herewith) along with supporting documents, copies of the relevant certificates issued by the Institution of Engineers, Institute of the Valuers, Registration Certificate of GST (if Applicable) and all certificates of experience shall be enclosed (as per enclosure) by the applicant. Incomplete applications or unsigned applications shall be summarily rejected.
- 05. The Department reserves the right to call for additional documents/ information from the applicants. The applicants shall submit all requisite documents on or before <u>05.03.2021</u>. After applicants are short-listed, it will be verified that they have not come in adverse notice of the Customs and DRI, GST etc., before they are approved for empanelment.
- 06. After scrutiny and evaluation, applications will be referred to the Institute of Engineers (India), Kolkata, who will verify their eligibility to evaluate second hand / old & used capital goods, machinery etc. On receipt of recommendation from the Institute of Engineers (India), empanelment for valuation as per the terms and conditions of this Commissionerate will be finalized.
- 07. The empanelment will be done through process of formal interview by a panel of officers of rank of Additional Commissioner of Customs / Joint Commissioner of Customs. The dates of interview and name of applicants / persons shot-listed for interview will be published on the website of this Commissionerate i.e., <a href="http://apcustoms.gov.in//">http://apcustoms.gov.in//</a>
- The applicant, in case of firm/company shall sponsor such employees / partners/ directors, who have the requisite qualification and experience for interview. Only such persons who are employees/ partners/ directors who have appeared and qualified in the interview will be allowed to carry out the Inspection/ Valuation of imported goods. At the time of empanelment, the Public Notice notify the Firms/ Directors with the names of such employees/partners/directors that can carry out the Inspection/Valuation.
- 09. On empanelment of Chartered Engineer, this Office will issue a Public Notice mentioning the names and addresses of the Chartered Engineers who can be contacted by the Importers/ Custom Brokers in terms of CBIC Page 2 of 13

Circular No. 07/2020-Customs dated 05.02.2020, the list of the selected candidates will be published on the website of this Commissionerate i.e., <a href="http://apcustoms.gov.in//">http://apcustoms.gov.in//</a>.

- 10. On selection, such Chartered Engineers have to submit their half yearly self-appraisal i.e., for the period from April to September and October to March, report in this office to assess their performance by end of October and by the end of April respectively to assess their performance to decide whether they are fit to continue or not.
- 11. The importers/ Trade/ Customs Brokers shall only use services of any of the empanelled Chartered Engineers who have requisite specialization in that field/ faculty for assisting the Customs Officers for valuation of machinery/ goods. The Fees/ Service charges as claimed by the Chartered Engineers shall be borne by the importers/ CHA/ Trade as applicable. Department shall not be responsible for non-payment/ Short-payment of fees for services availed in this regard by the importers/ CHA/ Trade.
- 12. The procedure of accepting the Valuation certificates from PSIA listed in Appendix-2G of the Hand Book of Procedures (2015-2020) Volume-I shall be discontinued upon the notification of empanelment of Chartered Engineers, in terms of CBIC Circulars No. 07/2020-Customs dated 05.02.2020. In the light of the same, such PSIAs with requisite qualification may make an application in response to this notice for consideration of empanelment as the Chartered Engineers, under the jurisdiction of this Commissionerate.
- 13. All the Chartered Engineers empanelled under the jurisdiction of this Commissionerate, as on date, shall be discontinued upon the notification of empanelment of Chartered Engineers, in terms of CBIC Circulars No. 07/2020-Customs dated 05.02.2020 and hence, the Chartered Engineers empanelled under the jurisdiction of this Commissionerate, as on date, shall have to submit applications for consideration of their empanelment, afresh.
- 14. Submission of any wrong information / valuation would result in suspension / cancellation of Candidature/ Membership from the panel and also attract Penal Provisions under the Customs Act, 1962.

- 15. The submission of application does not bestow any right for selection. The Department reserves the right to accept or reject any of the applications received for which no claim of the applicant shall be entertained.
- 16. Before examination/valuation of goods, AC/DC (Docks) shall be at liberty to allow only such Chartered Engineers who have domain knowledge/ expertise of valuation, examination of such goods.
- 17. The contents of this Public Notice may be publicized and brought to the knowledge of the member constituents of the Trade. The Public Notice and Performa may be downloaded from the website of website of this Commissionerate i.e., <a href="http://apcustoms.gov.in//">http://apcustoms.gov.in//</a>.
- 18. The duly filled and signed application along with all the required documents shall be submitted by Registered post/ Speed Post to The Additional Commissioner of Customs, Customs Commissionerate (Preventive), Industrial Estate, Auto Nagar, Vijayawada-520007.
- 19. The last date of submission of application is 05.03,2021 up to 16.00 hrs.

#### **ANNEXURE-B**

# I. Eligibility criteria for Empanelment of Chartered Engineer and other conditions::

- 1.1 All Chartered Engineers (CE for short) empanelled by Customs shall be governed by the provisions of the Public Notice and Instructions issued by the department from time to time.
- 1.2 While conducting a valuation, CEs have to comply with Internationally accepted Valuation Standards (IVS) as applicable plant and Machinery(IVS300)
- 2. Age:: The minimum age of Chartered Engineers in case of Individual applicant at the time of making application for empanelment with th Department shall be 30 years. In case the applicant is a Firm/ Company, the Engineers who will be deployed for Inspection and Valuation shall be of age above 30 Years. The maximum age limit shall be 70 years.
- 3. Qualifications and Previous work experience:: It is necessary that a CE posses proper educational qualifications which make him competent to carry out the task of valuation of machinery. In addition, relevant work experience is also important. Persons possessing the following educational qualifications and work experience shall be eligible for empanelment as CEs:
- A Educational Qualification: Bachelor's degree in Mechanical, Electrical, Production, Industrial, Computer, Electronics from a Universityy or Institution recognized by Government of India

  B Work Experience: FIVE years of work experience in the field of valuation of plantanti machinery after completion of the degree or equivalent

  C Additional Requirement / Remarks:: Preference shall be given to Applicants who have compacted certificate course in valuation of plant and machinery recognized by AICTE.

  D Membership of any one national or international body of Appraisers/ Valuers is mandatory.
- 3.1 Applicants empanelled on the basis of criteria of qualification and certifications {Prescribed hereinabove shall be eligible for empanelment provided they have not been de-listed /de-panelled / removed for unsatisfactory performance and/or for negligence and/or for professional misconduct and/or for any fraudulent activity and/or for any other reason whatsoever, at the discretion of the Department.

### 3.2 Qualifications and Previous Work Experience:

a. In case of empanelment of partnership firms&companies for undertaking valuations, the qualification and experience shall apply to all partners and key personnel/directors respectively the partnership firm and company unless otherwise specified.

- b. Experience of the CE shall be calculated from the date of his/its first empanelment with any State/ Central Government Department / PSU/Scheduled Banks.
- c. CEs should have thorough knowledge of the industry concerned and also the typeof machinery to be valued.
- d. CEs should constantly update their knowledge base by actively participating in various continuous education programmes including seminars, conferences, workshops, training programmes etc.,

#### e. References:

- (i) Applicant Chartered Engineers should provide evidence of previous work experience to the Department. Reference checks on applicant CE shall be carried out by the Department before empanelling on its panel to verify the competence, performance and service quality of applicant CE.
- (ii) For the purpose, applicant CE shall necessarily submit at least Two Reference letters from the Government Departments / any other Public sector banks / financial institutions /DRT / courts / undertaking where the CE had done valuations previously, obtained on letter head and duly signed by a senior level official at zonal/ head office and bearing rubber stamp of the issuing office.
- 4. Retired Staff Members: A retired staff member who is otherwise eligible for *empanelment* may also be considered for empanelment by the Department subject to following restrictions:
- (i), No punishment/ penalty arising out of disciplinary proceedings has been imposed upon him/her either during the service career or subsequent to his/her superannuation.
- (ii) No disciplinary / criminal /judicial proceedings are contemplated/pending subsequent to his/her superannuation from the service.

# 5. Other Conditions and Declaration-cum-Undertaking:

In addition to the above eligibility criteria, the following are the other conditions to be fulfilled by applicant CE:

5.1 The CE (Individual/ Sole-Proprietor/ all partners/ all directors) is a citizen of India / the entity is a body corporate registered in India.

# 5.2. The CE has a clean track record in as much as

- (i) The CE has not been removed / dismissed from valuation related service / previous employment earlier.
- (ii) The CE has not been found guilty of misconduct in professional capacity.
- (iii) The CE has not been convicted of any offence and sentenced to a term of imprisonment.
- (iv) The CE has not been convicted of an offence connected with any proceeding under the Customs Act, 1962, Central Excise Act, 1944. Service ax and GST provisions.

- (v) The CE has no complaints registered against him/it with CBI and or Police and or any Court of Law. The CE is not an undischarged insolvent.
- 5.3. The CE/ the Firm/ all the Partners of the firm and, the company and all the directors of the company shall each possess PAN Card.
- 5.4. The CE possesses required Goods and Services Tax Registration Number (not mandatory)
- 5.5 All the Directors of the Company shall each have DIN allotted to them.
- 5.6. The CE shall comply with the guidelines, standards and procedures, and abide by the code of conduct prescribed and as amended by the Department from time to time.
- 5.7. The CE shall act with an independence, integrity and objectivity; shall undertake all valuation works with an independent mind and shall not come under any influence of anybody.
- 5.8 The CE shall not undertake valuation of any imported goods that may be assigned to him/it from time to time in which he/the firm/the company/any of the partners/any of the directors/any of his/its employees have direct or indirect interest in the goods/machinery being valued.
- 5.9. The CE shall complete the assignment of valuation and submit duly signed [by lead CEs in case of Company] Valuation Report within the timeframe stipulated by the Department.
- 5.10. The CE shall not conceal or suppress any material information and facts prejudicial to the interest of the Department and shall make a complete and full disclosure at the time of application for empanelment, and should disclose immediately to the Department any such developments that may take place during the tenure of his / its empanelment with the Department.
- 5.11. The CE shall keep the Department informed immediately of any happenings or events that would make him/ it ineligible for empanelment.
- 5.12. For any negligence, lapses, professional misconduct and/or unfair practices resorted to by CE whether with the Department and/or other institutions; his/its empanelment with the Department will stand cancelled without further reference.

#### NOTE::

- 1. The above conditions apply to the individual, proprietor in case of sole proprietary concern, all individual partners and firms in case of partnership firm, all directors and company incase of company;
- 2. Applicant CE shall submit to the Department declaration-cum-undertaking to the above effect duly executed on non-judicial stamp paper of requisite value (individual/sole-proprietor / all partner s of the firm / all directors of the company in both representative and personal capacity) at the time of his/its empanelment.

# 6. Conditions of Conduct for Chartered Engineers::

All CRs empanelled with the Department shall strictly adhere to the following code of conduct.

### 6.1 Integrity and Fairness

- 6.1.1. A CE shall, in the conduct of his/its business, follow high standards ofintegrity and fairness in all his/its dealings with his/its clients and other CEs.
- 6.1.2. A CE shall maintain integrity by being honest, straightforward, and forthright in all professional relationships.
- 6.1.3. A CE shall endeavour to ensure that he/it provides true and adequate information and shall not misrepresent any facts or situations.
- 6.1.4. A CE shall refrain from being involved in any action that would bring disrepute to the profession.
- 6.1.5. A CE shall keep the public interest foremost while delivering his services.

# 6.2. Professional Competence and due Care::

- 6.2.1. A CE shall render at all times high standards of service, exercise due diligence, ensure proper care and exercise independent professional judgment.
- 6.2.2. A CE shall carry out professional services in accordance with the relevant technical and professional standards that may be specified from time to time
- 6.2.3. A CE shall continuously maintain professional knowledge and Skills to provide competent professional service based on up-to-date developments in practice/ prevailing regulation/guidelines and techniques.
- 6.2.4. In the preparation of valuation report, the CE shall not disclaim liability for his/its expertise or deny his/ its duty of care, except to the extent that the assumptions are based on statements of fact provided by the company or its a auditors or consultants or information available in public domain and not generated by the CE.
- 6.2.5. A CE shall not carry out any instructions of the client in so far as they are incompatible with the requirements of integrity, objectivity and independence.
- 6.2.6. A CA shall clearly state to his client the services that he would be competent to provide and the services for which he would rely on other CEs or professionals or for which the client have a separate arrangement with other CEs.
- 6.2.7. A CE shall not deploy any son other than notified by Department to conduct any Inspection/Valuation. Deploying persons other than those listed/empanelled as CE by the Department will be considered as a case of misconstrict.

# 6.3. Independence and Disclosure of Interest::

- 6.3.1. A CE shall act with objectivity in his/its professional dealings by ensuring that his/its decisions are made without the presence of any bias, conflict of interest, coercion, or undue influence of any party, whether directly connected to the valuation assignment or not.
- 6.3.2. A CE shall not take up an assignment if he/it or any of his/ its relatives or associates is not independent in terms of association to the company. Page 11 of 13

- 6.3.3. A CE shall maintain complete independence in his/its professional relationships and conduct the valuation independent of external influences.
- 6.3.4. A CE shall wherever necessary disclose to the clients, possible sources of conflicts of duties and interests, while providing unbiased services.
- 6.3.5. A CE shall not use or divulge to other clients or any other party any confidential information about the subject company, which has come to his/its knowledge without proper and specific authority or unless there is a legal or professional right or duty to disclose.

### 6.4 Information Management::

- 6.4.1. A CE shall ensure that he/it maintains written contemporaneous records for any decision taken, the reasons for taking the decision, and the information and evidences in support of such decision. This shall be maintained so as to sufficiently enable a reasonable person to take a view on the appropriateness of his/its decisions and actions.
- 6.4.2. A CE shall appear, co-operate and be available for inspections and investigations carried out by the authority, any person authorized by the authority.
- 6.4.3. A CE shall provide all information and records as may be required by the authority, the Commissioner (Appeals), Appellate Tribunal etc..
- 6. 4.4. A CE while respecting the confidentiality of information acquired during the course of performing the professional services shall maintain proper working papers for a period of three years or such longer period as required in its contract for a specific valuation, for production before a regulatory authority or for a peer review. In the event of a pending case before any authority of Customs, the record shall be maintained till the disposal of the case.

#### 6.5. Gifts and hospitality:

- 6.5.1. A CE or his/ its relative shall not accept gifts or hospitality which undermines or affects his independence as a CE.
- 6.5.2. A CE shall not offer gifts or hospitality or a financial or any other advantage to a public servant or any other person with a view to obtain or retain work for himself/itself, or to obtain or retain any advantage in the conduct of profession for himself/itself.

### 6.6. Remuneration and Costs::.

- 6.6.1. A CE shall provide services for remuneration which is charged in a transparent manner, is a reasonable reflection of the work necessarily and properly undertaken, and is not inconsistence with the applicable rules.
- 6.6.2. A CE shall not accept any fees or charges other than those which are disclosed in a written contract with the person to whom he would be rendering service.

# 6.7. Occupation, employability and restrictions::

6.7.1. A CE shall refrain from accepting too many assignments, if he/it is unlikely to be able to devote adequate time to each of his/its assignments.

# 6.8. Negligence and professional mis-conduct by panel Chartered Engineers::

- 6.8.1. Sincerity and honesty apart, CE should be guided by the quality of diligence in inspecting the imported goods in detail and investigate, inspect and analyse it accordingly. He/it should take reasonable care in arriving at the valuation of the machinery entrusted.
- 6.8.2. CE may be accused of negligence if he/it disregard the following:: (i) Import of machineries of comparable values (ii) Inadequate physical inspection of the machinery. (iii) Failure to consider major defects in the structural defects in the machinery etc.,
- 6.8.3 Lapses may include conspiracy of CE with Importer/Exporter in under valuation/ over valuation, incomplete, false and/ or misleading report on the goods being valued.

#### 7. De-panelment::

- 7.1. For any professional misconduct of CE and/or where the Revenue suffers loss due to any negligence and/or lapses on the part of CE, it will initiate such action against him / it as deemed necessary. Keeping in view the gravity of the lapses and/or misconduct, the department may take following action(s):
- (i) Removal dif CE's name from its panel after giving him/it an opportunity of being heard followed by a written communication to that effect.
- (ii) Initiation of legal proceedings including filing of FIR, Criminal complaint before courts.
- (iii) Inform related professional bodies and institutions regarding misconduct of CEs.
