**PUBLIC NOTICE No. 05 / 2022 - Customs**

Subject: Customs – Empanelment of Chartered Engineers for valuation of  
 Second Hand Machinery, Goods etc., --Reg.

Attention of all the importers, Custom House Agents and the members of the Trade is invited to the Board's Circular No. 04/2008-Cus. Dt.12.02.2008 and the Circular No. 07/2020-Cus. Dt.05.02.2020 regarding the valuation of the imported second hand (old and used) machinery. Further, refer to the Public Notice No. 02/2021-Customs dt.29.01.2021 issued by this Office, inviting the applications from the qualified Chartered Engineers (Individual or Company) represented by the individuals of various branches of specialization for empanelment with the Krishnapatnam Custom House and the Kakinada Custom House under the jurisdiction of Customs Commissionerate (Preventive), Vijayawada, for valuation of imported old and used/ second hand machinery, computers, medical equipments, other capital goods, spare parts, moulds, photocopier, malfunction machinery etc.,.

02. In response to the same, thirty (30) Chartered Engineers have submitted their applications in the prescribed format for empanelment within the stipulated period of time. All these applications have been referred to the Institute of Engineers (India), Kolkata, to verify their eligibility and subsequently obtained the verification reports from their end. Accordingly, interviews were scheduled virtually, by a Panel of Officers as appointed by the

Principal Commissioner, on 26<sup>th</sup> and 27<sup>th</sup> of April,2022. Out of the 30 candidates, supposed to attend the virtual interview, the following 4 candidates by name Sri. Shaik Nazeer Hussain, Sri. N Jeya Prakash, Sri. Rama Prasad G K and Sri. Prabhakar Rao Kosireddy have not attended for the interview and hence they are not considered for the process of empanelment.

03. In this regard, the work load of such valuation issues has been reviewed for the period of past three years and it was revealed that there are no such valuation issues at Kakinada Custom House and a very minimal issues at Krishnapatnam Custom House i.e., 05 items/ 1 BE during 2019-20, 07 items/ 1 BE during 2020-21 and 13 items/ 1 BE during 2021-22. As the work load of such valuation issues is very minimal under the jurisdiction of this Commissionerate, it was decided to empanel appropriate number of Chartered Engineers only for the actual requirement based on following criteria viz., Knowledge on Customs valuation more specifically valuation of second hand/used machinery; past experience with Customs and the ability to fulfill the requests of valuation at Kakinada and Krishnapatnam Custom House under the jurisdiction of this commissionerate. Accordingly, the performance of the 26 candidates has been assessed by the Committee through the interviews conducted virtually on 26<sup>th</sup> and 27<sup>th</sup> of April,2022 based on their past experience in Customs valuation, present location of working, basics of valuation and the performance of the candidates during interview process etc.,. In accordance with the performance assessment and the actual requirement of the number of candidates based on the work load of such valuation issues and recommendations of the committee, the following 12 candidates have been empanelled for valuation of imported old and used/ second hand machinery, computers, medical equipments, other capital goods, spare parts, moulds, photocopier, malfunction machinery etc., under the the jurisdiction of Customs Commissionerate (Preventive), Vijayawada, with immediate effect and until further orders. 05. The importers/ Trade/ Customs Brokers shall only use services of any of the empanelled Chartered Engineers who have requisite specialization in that field/ faculty for assisting the Customs Officers for valuation of machinery/ goods. The Fees/ Service charges as claimed by the Chartered Engineers shall be borne by the importers/ CHA/ Trade as applicable. Department shall not be responsible for non-payment/ Short-payment of fees for services availed in this regard by the importers/ CHA/ Trade.

06. All the empanelled Chartered Engineers shall have to strictly observe the conditions stipulated by the Board vide Circular No. 07/2020-Cus.

Dt.05.02.2020 and have to prepare and furnish their verification certificates in form-B annexed to Boards Circular referred above. In case the Proper Officer has any doubt regarding the accuracy of the certificate issued by a Chartered Engineer in respect of a particular consignment, the Department reserves the right to refer the issue to another Chartered Engineer. Before examination/ valuation of goods, AC/DC (Docks) shall be at liberty to allow only such Chartered Engineers who have domain knowledge/ expertise of valuation, examination of such goods.

07. Submission of any wrong information / wrong certification of valuation would result in suspension / cancellation of Candidature/ Membership from the panel and also attract Penal Provisions under the Customs Act, 1962

08. The above empanelled Chartered Engineers shall have to submit a yearly self-appraisal report in the prescribed format in Annexure-I (enclosed herewith), to this office on or before 30<sup>th</sup> April of every Financial year, to assess their performance and to decide whether they are fit to continue or not. If the self appraisal report is not submitted within the stipulated period of time or found to be involved in any offence related to Customs Valuation, Classification etc., their empanelment is liable to be withdrawn.

09. The procedure of accepting the Valuation certificates from PSIA listed in Appendix-2G of the Hand Book of Procedures (2015-2020) Volume-I, is discontinued with immediate effect consequent on empanelment of the above Chartered Engineers vide this Notification, in terms of CBIC Circulars No. 07/2020-Customs dated 05.02.2020.

10. All the Chartered Engineers empanelled under the jurisdiction of this Commissionerate, as on date are de-notified with immediate effect consequent on empanelment of the above Chartered Engineers vide this Notification, in terms of CBIC Circulars No. 07/2020-Customs dated 05.02.2020. This Public Notice supersedes all the earlier Public Notices issued by this Office regarding empanelment of Chartered Engineers.
