# PUBLIC NOTICE No.04 /2023 - CUSTOMS

**Sub:** Customs - Implementation of Customs Notification No. 32/1997 dated 01.04.1997 in System under IGCR - Reg.

Attention of all Importers, Exporters, Custom Brokers, Trade and other Stakeholders is invited to the advisory No.03/2023 dt.01.03.2023 issued by Directorate General of Systems and data Management on Implementation of Customs Notification No. 32/1997 dated 01.04.1997 in System under IGCR.

- 2. Reference has been received from Customs field formations that the importers are unable to claim Customs Notification No. 32/1997 dated 01.04.1997 under IGCR (Import of Goods under Concessional Rate of Duty) Rules. In this regard, as per the clarification received from Board, the same has been implemented in System in the following manner.
- 3. Now, only one continuity bond (i.e. IGCR bond) is required to be executed by the importer while claiming above Notification in the Bill of Entry. The requirement of jobbing bond (Bond Type JB), which is being submitted by the importer at port of import, has been done away with. Instead, as stipulated under IGCR, the importer can claim the benefit of aforesaid jobbing Notification by filing Bill of Entry under IGCR. The detailed Advisory as mentioned in Para 1 above may also be referred for the purpose of declarations required to be filed in the Customs System for the purpose of IGCR.
- 4. This Public Notice should be considered as Standing Order for the purpose of officers and staff of department. Officers facing any issues may email to
