
Sub: SEVOTTAM – Implementation of SEVOTTAM in Krishnapatnam Custom House –

The Central Board of Excise & Customs had decided to roll out implementation of SEVOTTAM in the newly created Commissionerates strictly. The instructions for implementation of SEVOTTAM in Krishnapatnam Custom House has already been issued vide this Office file C.No.VIII/48/03/2015-CPC (SEVOTTAM) dated 14.01.2016. All the Officers and Staff shall strive to implement SEVOTTAM in Krishnapatnam Custom House and shall follow the instructions issued from time to time in this matter.

2. **Shri M. Rama Mohana Rao, Joint Commissioner of Customs, Krishnapatnam Custom House, Nellore will be the overall in-charge of implementation of SEVOTTAM.**

The requirements as per guidelines prescribed in CBEC Service Quality Manual (SQM)-3.0 Revision No.1 for implementation of SEVOTTAM shall be followed and after complying with the requirements, application for BIS certification shall be submitted to this Office for onward submission. The process shall be completed within three months from the date of issue of this Order.
