NOTICE FOR INVITING TENDERS FOR VALUATION OF IMPORTED MACHINERY FORMING PART OF PLANT & EQUIPMENT FOR SETTING UP A COLD ROLLED STEEL MILL ((MACHINERY IMPORTED BY M/s SRI VISHNUPRIYA INDUSTRIES LTD., PANYAM VILLAGE, KURNOOL DISTRICT, A.P- REGARDING

Sealed quotations are invited for valuation of Machinery parts of 6 High Mill and Skin Pass Mill placed in bonded warehouse area situated in the factory premises I.e. M/s Sri Vishnupriya Industries Ltd., Panyam Village, Kurnool district, A.P. M/s Sri Vishnupriya Industries Ltd., had imported Machinery from Italy & other countries in 1998, for setting up a Cold Rolled Steel Mill at Panyam, Kurnool district and had been placed at the Bonded Warehouse at the Factory site, to be redeemed by the Unit after payment of Customs duty. The machinery remained in the custody of the Customs and Central Excise as the unit had become defunct. There was a fire accident at the site on 03.05.2012 and damaged some machinery. The said goods disperse placed in the open area of bonded warehouse since 1998.

The office of the Assistant Commissioner of Customs, Customs Division, Tirupati requests offers from the chartered engineers / Approved/Registered valuers figuring in Customs Preventive Commissionerate, Vijayawada / income tax department list of empanelled Chartered Engineers/Approved/Registered valuers herein after referred to as 'Valuer', for the valuation service for the said goods herein after referred to as 'Work'.

Qualification and Scope of Work are given in the Annexure-1 attached. The terms and conditions of the tender and the Work are given in the Annexure-2 attached. Interested Valuers are requested to read all the documents carefully and put their signature along with their official seals in each page of the Tender document & price offer towards acceptance of the Scope of Work, Terms and Conditions. Submission of bids should be as per two bid system i.e., Technical and Financial Bid separately in two different sealed envelopes. These envelopes should be super scribed "Financial Bid" and "Technical Bid" and put inside a bigger envelope which shall be super scribed with the words, "TENDERS FOR VALUATION OF IMPORTED MACHINERY FORMING PART OF PLANT & EQUIPMENT FOR SETTING UP A COLD ROLLED STEEL MILL ((MACHINERY



Annexure – 1

Qualification criteria for chartered engineers / approved valuers

1. The Valuer should have experience in Valuation of Plant and Machinery goods.
2. The valuer should be a specialist in the field of Mechanical / Machinery ..
3. The Valuer should figure in the list of registered valuers / empanelled chartered engineers of Customs Preventive Commissionerate, Vijayawada / income tax department's list.
4. The Valuer should not have been black listed by any government agency or involved in any offence.
5. The Valuer should have sufficient human / material / technical resource.

Scope of work for the chartered engineer / approved valuer

1. The Valuer will provide full details of the basis of valuation in their report including physical description and condition of the goods, condition of package and storage along with photographs.
2. The Valuer will be responsible for the finding / suggestions / implications of their report on the assignments allotted.
3. The Valuer will take all necessary steps to ascertain the correct valuation including taking samples if considered necessary.
4. The Valuer will maintain secrecy of the work assigned to him and his report on valuation. He will not divulge any information that he may across at any stage of valuation to others in detriment to the interest of the department.

Annexure-2

Term and conditions of the TENDER and the work

1. The Valuer should undertake to inspect the goods with due care and diligence without damaging the goods being inspected.
2. On approval of the tender the approved Valuer has to enter immediately into an agreement with the Asst. Commr. of Customs, Customs Division, Tirupati agreeing to the terms and conditions, swearing to abide by the terms and conditions and other legal requirements.
3. The Valuer should undertake to complete the valuation work, including submission of valuation certificates, within two weeks from date of agreement.
4. The Valuer shall provide full details of the basis of valuation in their report including physical description and condition of the goods, condition of package and storage along with photographs.
5. The Valuer will maintain secrecy of the work assigned to him and his report on valuation. He will not divulge any information that he may across at any stage of valuation to others in detriment to the interest of the department.
6. The Assistant Commissioner of Customs, Customs Division, Tirupati reserves the right to rescind the contract without assigning any reasons.
7. The price offer includes all the activities in the process of valuation. No sum other than the accepted sum will be paid to the chartered engineer / approved valuer for the work done and valuation report submitted.
8. Payment will be made after the submission of valuation report only.
