TRADE FACILITATION CIRCULAR No. 01/2018

Sub : Customs - Refund of IGST – EGM related errors – Amendment of No. of container mismatch & container No. mismatch in EGM filed at ICDs – Regarding.

Attention of the Importers, Exporters, Export Promotion Councils, General Trade, Custom Brokers, Custodians, Shipping Liners / Shipping Agents, Container Freight Stations (CFSS) / Inland Container Depot and all concerned is invited to the Public Notice No's. 09/2018 – Customs, dated 27.02.2018 and 12/2018-Customs dated 26.03.2018 issued by this office in compliance with the CBEC's Circular No's 05/2018-Customs, dated 23.02.2018 and 08/2018-Customs, dated 23.03.2018, respectively on alternative mechanism with Officer Interface to handle EGM related errors.

2. Attention of all the above stake holders is invited to the fact that in a number of cases of exports through ICD, IGST refund could not be granted due to EGM Errors occurring under code SBO06.

3. The following EGM Errors are occurring under code SBO06 :

- M** – Gateway Port code given in truck summary different from actual gateway port
- N** – No. of Containers Mismatch
- C** – Container No. Mismatch
- T** – Nature of Cargo Mismatch
- L** – LEO Date is greater than Sailing Date



On verification, the necessary amendment in the system shall be made. The shipping lines, thereafter, would have to file the supplementary EGMs for successful integration.
