**TRADENOTICE - 02/2023**

**Sub:** Implementation of Electronic Cash Ledger (ECL) – Difficulties being faced by Importers and Trade – Streamlining of clearance of goods -- Reg.

**Ref:** 1. Ministry's Order No. 2/2023- Customs (N.T) dated 11.04.2023  
2. CBIC Circular No. 9/2023 Customs dated 30.03.2023.

Kind attention is invited to the Ministry's Order, Board's Circular cited above and this office Trade Notice No. 01/2023 dated 06.04.2023, on the subject issue. Soon after implementation of electronic cash ledger w.e.f 01.04.2023, certain difficulties in making payment of Customs duty have surfaced and in order to resolve the issues a special team of officers have been formed to review the issue case-by-case and suggest remedial measures in processing the goods.

2. In this connection, it is observed that issue pertaining to the duty payment with electronic cash ledger is still to be resolved. As such, the whole of interest payable under sub-section (2) of section 47 of the Customs Act, 1962, in respect of such goods, where the payment of import duty is to be made from the amount available in electronic cash ledger (ECL), since been waived and same procedure is further extended by the board from 11.4.2023 to 13.04.2023.

3. The team constituted for the purpose of resolving the issues pertaining to payment of duty will continue to be operational ( including during the holidays falling in between) and available till 18<sup>th</sup> April, 2023 to ensure uninterrupted clearance of cargo. Therefore, all such cases are required to be brought to the notice of the following officers, after making necessary efforts in making the payment along with a copy of (i) mail sent to ICEGATE helpdesk (icegatehelpdesk@icegate.gov.in), and (ii) copy of error screen shot.
