PUBLIC NOTICE NO.05/2016-CUS.

<u>Sub</u>: Customs – Movement of import containers from M/s.Krishnapatnam Port Container Terminal (KPCT) to M/s.Krishnapatnam Bay Area CFS (KBACFS) - Issue of Public Notice - Reg.

M/s.Krishnapatnam Bay Area CFS Pvt. Ltd. (now M/s.Seabird Distrikpark (Krishnapatnam) Pvt. Ltd. (SDKPL)) has been notified for handling, storage of Import, Export Cargoes / Containers vide Customs Notification No.02/2015-Customs dated 05.10.2015 issued from file C.No.VIII/48/55/2015-Cus.Tech.

Subsequently, Krishnapatnam Port has recently issued the trade advisory, advising all the Shipping Lines about shift of Import operations from the port to CFS w.e.f. 14th January, 2016.

The following set procedure need to be followed for moving import containers from M/s.Krishnapatnam Port Container Terminal (KPCT) to M/s.Krishnapatnam Bay Area CFS (KBACFS).

- 1) All Shipping Lines filing IGM will mention CFS code **INKRI1KBA1** in the IGM and group code as **SBS** in Import Advance List (IAL) with immediate effect.
- 2) On the basis of IGM, KBACFS (SDKPL) is authorized to move the containers to their CFS for import examination and delivery after following the set customs procedures.
- 3) CFS will issue job order to KPCT requesting for delivery of containers. The job order will be endorsed by the Preventive Officer / Gate Officer, based on which KPCT will permit container movement to CFS.
- 4) KBACFS (SDKPL) shall maintain the turnaround time of trailers for movement of containers from KPCT to their CFS, which shall not be more than 45 minutes until unless for any specific reasons if any due to trailer break down, pathway change if any in emergency, etc.
- 5) KBACFS (SDKPL) shall provide daily movement reports to Customs indicating KPCT out time and CFS gate in time for meticulously monitoring the movements.
- 6) Any deviation from set procedures and in turnaround of trailers shall be brought to the notice of concerned Customs authority (Preventive) promptly.
