## PUBLIC NOTICE NO.06/2016-CUS

<u>Sub</u>: Customs - Valuation of Second Hand Machinery, Goods etc - Empanelment of Chartered Engineers - Reg.

Attention of all Importers, Custom House Agents and the members of the Trade is invited to the Boards Circular No.4/2008-Cus dtd.12.02.2008 (F.No.467/34/2006-Cus.V) regarding the valuation of the imported second hand (old and used) machinery.

- 2. In addition to the Chartered Engineers/ Inspection and Certification Agencies recognized by the Ministry of Commerce and enlisted in the Appendix 5 of the Handbook of the Procedures 2009-14 as amended and in the supersession of the earlier Trade Facilitation Circular Nos.02/2012 dated 06.02.2012, 01/2013 dated 16.01.2013 and 02/2013 dated 23.01.2013 issued in this regard following Chartered Engineers / Inspection and certification Agencies are empanelled for valuation/ examination of the second hand(old and used) machine imported at Kakinada Customs House; Krishnapatnam Port Custom House as per Board's Circular No.4/2008-Cus dtd.12.02.2008 with immediate effect and until further orders.
- Keeping in view of increase in the volume of Imports and Exports at Custom Houses of Customs Preventive Commissionerate, Vijayawada, a need was felt to enlarge the list of empanelled Chartered Engineers. Hence, A Public Notice No.25/2015-Cus dated 16.10.2015 was issued inviting applications from the eligible Chartered Engineers for empanelment for Valuation of Second Hand Machinery, Goods etc. The following Chartered Engineers have submitted applications for empanelment within the stipulated period.

- 4. On the basis of Verification Report in respect of the above four Chartered Engineers, received from the Executive (Membership), M/s.The Institution of Engineers (India), Kolkata, vide letter No.Memb/SM/M-58 dated 08.02.2016, they have been empanelled as Chartered Engineers for Valuation of Second Hand Machinery, Goods, etc., in the jurisdiction of Customs Preventive Commissionerate, Vijayawada.
- 5. The Chartered Engineers empanelled by Customs Preventive Commissionerate, Vijayawada, who are conducting valuation of second hand machinery / capital goods etc. imported through Krishnapatnam Port, Nellore, Kakinada Port, Kakinada have to submit yearly self appraisal report in the format prescribed in Annexure-I of this Trade Facilitation Circular, to the Commissioner before 30th April of every Financial year to assess his performance and to decide whether he is fit to continue in the panel.
- 6. The Self-appraisal reports to be scrutinized by SIIB Section of this Commissionerate / jurisdictional Joint / Deputy / Assistant Commissioner, Krishnapatnam Port, Nellore / Kakinada Port, Kakinada and a report is to be submitted to the Commissioner for taking further action. If the empanelled Chartered Engineer is found to be involved in any offence relating to Customs classification, valuation, mis-declaration and any violation of the provisions of the Customs Act, 1962 and its allied Acts, Rules & Regulations, his empanelment would be withdrawn and appropriate action would be initiated under the provision of the Customs Act, 1962.
