Sub: Customs -Setting up of 'Customs Clearance Facilitation Committee(CCFC) for ICD, Marripalem– Reg.

Attention of Trade, Customs Brokers and all other Stake Holders is invited to Board's Circular No.44/2016-Customs, dt.22.09.2016 regarding Setting up of "Customs Clearance Facilitation Committee"(CCFC) for Land Customs Stations and Inland Container Depots.

2. In accordance with direction of the Board vide Circular No. 44/2016-Customs, dt.22.09.2016 Customs Clearance Facilitation Committees (CCFC) have been setup at ICD, Marripalem falling under the Customs Preventive Commissionerate, Vijayawada, with effect from <u>28-12-2016</u>. The Customs Clearance Facilitation Committees (CCFC) would be headed by the Commissioner of Customs, Customs Preventive Commissionerate, Vijayawada. The final list of members of Customs Clearance Facilitation Committees (CCFC) at ICD, Marripalem are enclosed as Annexure.

3. Terms of Reference for the Customs Clearance Facilitation Committee (CCFC) are as follows :

(i) Ensuring and monitoring expeditious clearance of imported and export goods in accordance with the timeline specified by the parent Ministry/Department concerned;

(ii) Identifying and resolving bottlenecks, if any, in the clearance procedure of imported and export goods;

(iii) Initiating Time Release Studies for improvement in the clearance time of imported and export goods;

(iv) having internal consultations to speed up the clearance process of imported and export goods and recommending best practices thereto for consideration of CBEC/ Department / Agencies concerned; and

(v) Resolving grievances of members of the trade and industry in regard to clearance process of imported and exported goods.

4. The Customs Clearance Facilitation Committees shall meet once in a quarter .
