
Subject : Customs – Procedure for grant of self sealing permission to the Exporters in GST regime consequent to CBEC Circular No.26/2017-Customs, dated 01/07/2017 & 36/2017-Customs, dated 28/07/2017 – regarding.

Attention of all officers and concerned staff of Customs Preventive Commissionerate , Vijayawada is invited to the Public Notice No:28/2017, dated 05.09.2017 forming Export Promotion Divisions / Circles (EPDs / EPCs) in the jurisdiction of this Commissionerate and Trade Facilitation Circular No. 01/2017, dated 06.09.2017 prescribing the procedure to be followed for grant of self sealing permission.

2. The procedure prescribed in the above said Trade Facilitation Circular No.01/2017, dated 06.09.2017 shall be noted for strict compliance by the officers and staff of concerned field formations of Commissioner of Customs (Preventive), Vijayawada. The jurisdictional Deputy / Asst. Commissioner in-charge of EFD shall submit the verification report to Hqrs. Office within 24 hours of receipt of the same from the concerned Superintendent. In case where the visit report of the Superintendent / Inspector regarding viability of the

stuffing at the factory / premises is not favorable, specific reasons for the same shall be furnished.

3. All concerned are requested to monitor and supervise the implementation of the prescribed procedure by formations under their charge without any deviation to the guidelines / instructions communicated by the Board in this regard.
