Subject : Customs – Compliance with Board guidelines in Wood packing material in exports – regarding.

Attention of all officers and concerned staff of Customs Preventive Commissionerate, Vijayawada is invited to Board's Circular No. 14/2009/Cus dated 06-05-2009 and Circular No. 13/2011-Cus dated 28-02-2011 wherein attention was invited to Provision of Plant Quarantine (Import of Goods in India) Order, 2003 which also outlines mandatory requirements of compliance of ISPM for imported goods. Accordingly, Board Circular No.39/2004-Customs dated 03-06-2004 and instructions dated 02-04-2009 were issued to Customs field formations to implement the provisions of ISPM compliance. It has been reiterated that the instructions and guidelines issued on the subject should be followed scrupulously..

2. In line of the said instructions issued by the Board, procedure has been reiterated vide this Office Public Notice No. 14 / 2017 dated 04-08.2017, for strict compliance by the officers and staff of concerned field formations of Customs Preventive Commissionerate, Vijayawada.

3. All concerned are requested to monitor and supervise the implementation of the prescribed procedure by formations under their charge without any deviation to the guidelines / instructions communicated by Board in this regard.
