**PUBLIC NOTICE No.21/2015-CUSTOMS**

**Sub: Inviting applications under Regulation 4 of Customs Brokers Licensing Regulations, 2013 for conducting the written examination under Regulation to be held on 28-01-2016 - Reg.**

Kind attention of the Trade and all public is invited to the Regulation 4 of **Customs Brokers Licensing Regulations, 2013 (CBRL, 2013)**.

2. In terms of the Customs Brokers Licensing Regulations, 2013, applications are invited in the prescribed format of **FORM-A** available in the Notification No.65/2013 (NT) Dated 21-06-2013 for the **WRITTEN EXAMINATION**, as per the Notice issued by the Directorate General of Inspection, Customs and Central Excise, New Delhi.

3. As per the Notice of the Directorate General of Inspection, Customs and Central Excise, New Delhi, a written examination under Regulation 6 of Customs Brokers Licensing Regulations, 2013, will be held on **28-01-2016** at Customs Preventive Commissionerte, Vijayawada. The time and venue of the examination will be intimated later. The syllabus for written examination mentioned in the Regulation 6(7) of Customs Brokers Licensing Regulations, 2013.

4. The applicant shall be a Citizen of India and should fulfill the conditions stipulated in Regulation 5 of Customs Brokers Licensing Regulations, 2013. Before applying, the Applicant should ensure that they are eligible for written examination. Any deviations noticed against the conditions of said Regulations, the applications will be summarily rejected. The applicant should go through the Customs Brokers licensing Regulations, 2013 carefully vide Notification No. 65/2013-Customs (NT) dated 21-06-2013.

5. The last date of receipt of applications is **17-11-2015**. All the applicants who intend to take examination may submit their applications in the prescribed format **Form-A** to the Joint / Deputy / Assistant Commissioners of Custom Houses at Kakinada and Krishnapatnam and ICD, Marrisalem Village, Guntur, who in turn may forward the same to the Headquarters Office, Customs Preventive Commissionerate, Vijayawada, on or before **20-11-2015** along with the following documents.

- (i) Two Recent Passport size Photographs self attested (on the front side).
- (ii) Self attested documents on **Citizenship, Educational Qualifications & Financial Requirements** as per Regulation 5 of Customs Brokers Licensing Regulations, 2013.

6. While forwarding the application forms, concerned Joint / Deputy / Assistant Commissioners of Customs, Krishnapatnam Custom House, Nellore, Kakinada Custom House, Kakinada and ICD, Marrisalem, Guntur should verify and ensure that the data / particulars furnished by the applicant are true and correct.

7. Eligible candidates will be allotted Roll Numbers and Hall Ticket Numbers would be sent to the Custom Houses / ICD. The list shall be displayed at the respective Customs Formations of Krishnapatnam Custom House, Nellore, Kakinada Custom House, Kakinada and ICD, Marripalem, Guntur and also at the Notice Board of Commissioner's Office, Auto Nagar, Vijayawada. The applicants may collect the Hall Tickets from these Custom Houses / ICD.
8. The candidate who successfully passed written examination shall be called for an oral examination. A candidate needs to pass both Written & Oral examinations to qualify for issuance of license.
9. The candidates have the option to answer either in English or in Hindi. The date of written examination shall not change even if it is declared a holiday.
10. In case declarations made by the applicant are found to be incorrect, the application is liable to be rejected or license is liable to be cancelled.
11. Applications received prior to the issuance of this Public Notice or the applications received after the due date, i.e., 17-11-2015 shall not be considered and no further correspondence in the matter will be entertained.
12. The concerned Joint / Deputy / Assistant Commissioners of Customs Formations are directed to bring the contents of the said Public Notice to the knowledge of all Trade Associations, Chamber of Commerce, Exporters, Importers, Customs Brokers and all the concerned.
