TRADE FACILITATION CIRCULAR No. 02/2017

Sub: Customs - Procedure for grant of Self sealing permission to the Exporters in GST regime consequent to CBEC Circular No.26/2017-Customs, dated 01/07/2017 and transfer of Customs functions presently being performed by the Central Tax formations – reg.

Attention of the Importers, Exporters, General Trade, Custom Brokers, Custodians, Shipping Liners / Shipping Agents, Container Freight Stations (CFSs) / Inland Container Depot and all concerned are invited to the Trade Facilitation Circular No.01/2017, dated 06/09/2017 issued by this office and the Public Notice No.41/2017, dated 15/12/2017 issued from file C. No. VIII/48 /18 /2017 -Cus.Tech. re-organising the formations in the jurisdiction of the Commissioner of Customs (Preventive), Vijayawada.

2. In partial modification of the Trade Facilitation Circular No.01/2017 referred above, the exporters who are seeking self-sealing permission of export containers shall file their application in Annexure-A along with required documents with the jurisdictional Deputy/Assistant Commissioner of Customs, Customs Division. The Customs Divisions and their jurisdiction are as specified in this office Public Notice No.41/2017, dated 15/12/2017. The location and jurisdiction of the Customs Divisions are furnished hereunder for ease of reference.

- 3. The application for self-sealing by the exporter will be acknowledged by the Inspector / Superintendent working in the jurisdictional Customs Division and the premises of the exporter will be verified by the Superintendent nominated by the Deputy/Assistant Commissioner in-charge of the Customs Division who shall submit the verification report. The Deputy/Assistant Commissioner shall forward the verification report to the Hqrs. Office.
- 4. Any reference to Export Facilitation Division (EFD) mentioned in the aforesaid Trade Facilitation Circular No.01/2017, dated 06/09/2017 may be read as reference to Customs Division. The Export Facilitation Centres are no longer in existence consequent on issuance of Public Notice No.41/2017-Customs, dated 15/12/2017.
- 5. All other procedure prescribed in the Trade Facilitation Circular No.01/2017 shall be followed.
- 6. Further, the Customs work which is presently being handled by the Central Tax formations shall be executed by the jurisdictional officers of the Commissioner of Customs (Preventive), Vijayawada with effect from 01.01.2018 i.e., from the date of effect of Notification No.82/2017-Customs (NT), dated 24.08.2017, as amended.

- 7. The Customs functions which were presently being handled by the Central Tax formations includes
 - i) Duty free imports by EOUs/EHTP/STP units, issuance of rewarehousing certificate, bond to bond transfer, collection of duty of Customs in case of disposal of capital goods or goods other than capital goods as such by the unit, Execution of B-17 bond, demand of duty of Customs in case of default in NFE, non accountal of goods collection of cost recovery charges, MOT etc
 - ii) Duty free imports, imports at concessional rate of duty subject to end use condition under Customs (Import of goods at concessional rate of duty for manufacture of excisable goods) Rules, 2016, execution of bond, monitoring of utilization and demand of customs duty in case of default
 - iii) Installation certificate for goods imported under EPCG scheme
 - iv) Adjudication of offences and demand of customs duty in respect of SEZs etc.
- 8. In view of the above, any applications, execution bonds, filing of returns etc presently being filed before the Central Tax authorities shall be filed before the jurisdictional Deputy / Assistant Commissioners of Customs Divisions and Hqrs. Trade Facilitation Centre in the jurisdiction of the Commissioner of Customs (Preventive), Vijayawada.

 Action to be taken in terms of decisions taken in this Public Notice should be considered as standing order for the purpose of officers and staff.
