3. At the outset, the Commissioner of Customs welcomed the Exporters, Custodian, Customs Broker Licence holders and the Officers of ICD, Mairipalem.

4. As no previous issues are pending, the Chairperson has asked for any new points.

**New Points:**

5. Shri Ramana Murthy of ITC has stated that containers without e-sealing sent directly to CFS at KP Port are being de-stuffed and re-stuffed and this is creating problems for them as they do not have necessary infrastructure to re-pack their material after de-stuffing. The Chairperson has directed that any examination of containers whether e-sealed or not shall be done only as per RMS instructions.

**(Action: JC, KPCH)**

6. Shri Sandeep of M/s Leap Intl has stated that IGST refund has been rejected in case of exporters claiming higher rate of drawback during the period from July, 17 to October, 2017. The Chairperson has observed that no refund of IGST will be allowed in case of claiming of higher rate of drawback.

**(No action. Point closed)**

As there were no other issues, the Commissioner took up the issue of AEO (Authorised Economic Operator) applications and requested the exporters and CHAs present to submit their revised applications after making good the deficiencies pointed



out by the DGPM, Hyderabad. The Commissioner assured the exporters that the Team formed for this purpose at ICD, Mairipalem will help the exporters in filing the revised AEO applications. The Commissioner explained the benefits of the AEO status to the exporters and advised them that they should avail the benefits of the facilitation extended to the AEO Status holders. The Commissioner stated that the AEO issue should be taken up on priority basis.

8. Before concluding the meeting, the Commissioner has asked the trade to present their queries / suggestions, if any, for betterment of the procedures viz. ease of doing business. All the members expressed their pleasure in timely / immediate clearances of exports.
