3. The vessel can be inspected for the works to be carried out at the location as mentioned above on any working day between 10 am to 5 pm with prior intimation to the Superintendent (Preventive), Krishnapatnam Custom House on phone no. 9154347720 or 9948377009. Scope of work for Deck side and Engine side may be discussed during inspection of vessel.
4. You may also inspect fitted systems and equipment of vessel and their controls for any defects.
5. The firm should be an authorized dealer of Mercury Marine (OBM), having workshop facility for overhauling of OBM and should be able to arrange all requisite spares.
6. For Service routines & repair works of Deck side and OBMs of Mercury Mariner 250 HP EFI Engines, the firm should have an experience of at least 03 (three) years with sufficient manpower and presently handling similar nature of work with workshop facility for overhauling of OBMs and should be able to arrange all requisite spares.
7. All spares, consumables, paints, oil & lubricants, materials etc, required to carry out repairs shall be supplied by the firms including crane services and transportation, if required.
8. After completion of works, sea trials at full powers to be conducted for satisfactory performance of all machineries, equipment and systems fitted on the vessel and payment will be released only after completion of all work. No partial payment will be released for partial work done.

9. Financial Bid of only those firms will be considered who are found eligible in their Technical Bid.
10. The bidder shall arrange necessary Insurance coverage for any persons deployed by him/her. This office shall not entertain any claim arising out of mishap, if any that may take place. In the event of any liability/ claim filing on this office, the same shall be reimbursed/ indemnify by the bidder.
11. Bidder shall be fully responsible for theft, burglary, fire or any mischievous deeds by him/her or his/her staff.
12. The work carried out should be **guaranteed for a period of at least twelve months** from the date of successful trials of the vessel.
13. The firm is required to submit **10% of Order value as PBG** (Performance Bank Guarantee) i.e. Twelve months and same will be released post completion of guarantee period provided no problems arise/ problems arise are rectified during guarantee period, free of cost.
14. The firm is required to complete the repair works and sea trials within 15 days from the date of work order. In case the repairs are not completed within the time frame, liquidated damage of Rs. 5000/- per week till completion of works and sea trials shall be deducted from the payment.
15. Original Mercury parts must be used for replacement of any damaged part.
16. The charge quoted should be inclusive of all taxes and other charges.
17. No escalation of price whatsoever would be allowed during the ongoing work of the contract.
